## **UNDERTAKING**

Undertake on behalf of my son/ward and myself to fully abide by the rules of the College given below:-

- My son/ward shall maintain his identity as student by wearing prescribed College uniform and putting on College badge.
- 3. My son/ward shall be regular and punctual and would not play truant (bunk off)
- My son/ward shall restrain himself from misconduct, disputes, political affiliations or any act of violence. Incase of any such involvement we will accept the judgment given by the Principal under College rules and regulations including expulsion.
- 5. (a) I understand that the following activities are interpreted as Misconduct on the part of Student/Parents/Guardian:-
  - (i) Insulting attitude with the Principal, teaching staff and other non teaching staff.
  - (ii) Holding a meeting, gathering, taking out processions in or around the College campus or bringing outsiders / expelled students of the college, students of other Colleges / Schools or using any room or part of the building for undesirable activities.
  - (iii) Bringing or keeping any type of weapon and bringing or consuming or encouraging the consumption of cigarettes, alcoholic products, drugs and narcotics and indulging in acts of moral turpitude.
  - (iv) Indulging in any kind of unfair means, malpractice in examinations and coercion by any means.
  - (v) Damaging College property in any manner or by any act which might be a disgrace to the institution.
  - (b) Disciplinary action against the student may take one or more of the following forms depending upon the nature and severity of the offence to be determined by the Principal.
    - (i) Appropriate fine may be levied.
    - (ii) The student may be placed on probation for a fixed period. If during the period of probation, he fails to improve his conduct/discipline, he may be rusticated or expelled/withdrawn.
    - (iii) The student may be suspended / expelled from the rolls of the College.
- I shall not hold College responsible for any unfortunate accident or incident which may occur while my son/ward is at College or one the way to / from the College.
- 7. My son/ward will have to qualify all the home examinations (all papers) to become eligible for admission to the FBISE or UCLES. In case he does not qualify, the College reserves the right to withhold his admission and my son/ward and I shall not challenge the decision of the Principal at any level including the Court of Law.
- I shall pay the College dues regularly within the specified period. I understand that College dues once paid cannot be refunded. Furthermore I shall pay the dues for the whole academic session as determined by the College.
- 9. In case of changes in address or telephone, it shall be our responsibility to inform the College in writing immediately.
- My son/ward and I have studied and understood all the above mentioned rules and regulations and we accept them as binding on us.
